9. GOVERNMENT CONSULTATION ON HOUSING DEMAND

Members will be aware that due to the way housing numbers were calculated, the City Council recommended several applications in Whittingham for approval, because they did not have a 5 year housing supply based on the requirement of **507** homes pa. Subsequently, the limit was reduced to 269 homes pa. Against this figure, in April 2023, the City Council could demonstrate a 12.6 year supply of housing and applications for new development were refused. The newly elected Government is proposing to increase the figure to **662** homes pa.

Members are requested to comment on the consultation.
